1	C.2 Alternate I	As explained during the pre bid meeting, the purpose of the breakaway screw is to break off at a certain load. As seen from the literature (copy attached) the purpose of the screw is to adjust the length and not to break off at a pre determined load/tension. Kindly, clarify how the use of this screw will meet your requirement.
DMH RESPONSE: The contractor will be drilling the vent and masonry wall, and installing nylon sleeves. The contractor is supposed to screw the breakaway screws into the nylon sleeves up to the point of breakaway. The screws are not screwed into the vents. They pass through the vent and screwed into the sleeves.
