2. *Question: Are CBOs allowed to apply for this RFA without attending the pre-application conference?*

**Answer: A CBO may apply as the pre-application conference attendance is not mandatory yet strongly encouraged. Additionally, the Intent to Apply is part of the fillable PDF and will be submitted with the application.**

3. *Question: Please confirm/clarify that the \$70,333.67 per matched school is the amount available for a six month budget.*

**Answer: It is correct that \$70,333.67 per matched school is the amount available for a six month budget. The breakdown of this core funding is \$53,667 which supports a portion of the clinician’s salary to provide the prevention and early intervention services and the portion of funding for the clinician’s supervision at \$16,667.67 (Funding of supervisor at \$100,000 for a 1:6 supervisor to clinician ratio) is available for per matched school. The total of \$70,333.67 .**

4. *Question: What should I do if I don’t have a required attachment, or, the required attachment is not applicable to my organization?*

5. *Question: Please confirm that community-based organizations without IRS 501(c)3 tax exempt status are or are not eligible to apply for and be considered for funding under this RFA.*

**Answer: A community-based organization without a 501(c)(3) is eligible to apply and be considered for funding under this RFA.**

6. *Question: What is the impact of not having the IRS 501 (c)3 status?*

7. *Question: I just want to confirm that my agency is not a 501c and is a S-corp but we can apply for this school grant. I ask because i see in the required attachments the request for our 501c charter document from the IRS.*

**Answer: If you are a community-based organization in the behavioral health sector located in the District of Columbia, you are eligible to apply. Please see question #4 regarding required attachments.**

8. *Question: After reviewing the RFP, we are not sure if the Clinicians and key staff for the grant must be salaried employees or if they can be 1099 employees.*

**Answer: The staffing structure is up to the organization and the required template for Attachment E of the RFA asks for the supervision structure, capacity, and practice. A CBO may choose to use salary and/or 1099 employees within the CBO's staffing structure.**
