INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth and young adult tobacco access laws (FFY 2023 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth and young adult tobacco access rates (FFY 2024 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth and young adult tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth and young adult tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance

with youth and young adult tobacco access laws.

Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2023 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2024 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Please note that, in the FFY 2024 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel), as well as a database with the raw inspection data to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.



The District uses a randomized sample to determine the stores where compliance checks will be conducted. To minimize the risk of bias to the survey results, members of the team rotate to ensure variation in youth entering the store. In addition, the Synar team drivers park a safe distance away in an effort not to alert establishments that inspections are underway.

In FY2023, DBH established a relationship with the Department of Licensing and Consumer Protection, (DLCP) (which assumed the responsibility of the Department of Consumer and Regulatory Affairs) in enforcement of the District's tobacco laws as outlined in the Synar Protocol. In FY2024, DBH will be conducting merchant education, as well as work with Department of Licensing and Consumer Protection (DLCP) to receive the updated list of the vendors that are out of business so that their list can be updated.

Adult supervisors are trained using NCCPUD's established protocol.

Recruiting

- 1. NCCPUD identifies adult supervisors through prior experience as a youth inspector. Once youth age out of the youth inspector program they are eligible to apply as an adult supervisor.
- 2. DBH requires that adult supervisors selected have valid government identification with a photo, the minor's name, date of birth and address. Minor's selected must carry their government identification (e.g., Motor Vehicle Driver's License or non-driver's identification card) when involved in the Synar Survey Inspections.

Training

1. NCCPUD updates annually a standard Training Manual approved by DBH. The curriculum for Compliance Check Team members (including NCCPUD supervisors, DLCP, and DBH staff), provides an overview of the health and legal consequences of underage tobacco use, Synar requirements, and protocol including roles and

responsibilities. DBH and NCCPUD maintain a copy of the Training Manual that is available upon request.

2. NCCPUD provides annual mandatory trainings for the Compliance Check Team according to pre-determined dates in the annual work plan.

5b. Describe the methods used to recruit, select, and train youth and young adult inspectors.

All inspectors are recruited by the National Capital to Prevent Underage Drinking (NCCPUD), DBH's Synar contractor. This organization has a history of conducting citywide compliance checks as well as recruiting, select, and training youth inspectors for various programs throughout the District of Columbia. Youth inspectors are trained using NCCPUDs established protocol, which is based on their prior experience with compliance checks. A summary of the methods are provided below.

Recruiting

- 1. NCCPUD identifies qualified minors through several venues such as its youth advocates peer program and recommendations from high school and community-based officials. The majority of the minors that participate are honor students, have leadership roles in their school and community and are involved in pro-social activities.
- 2. NCCPUD requires that all minors selected for the programs have written consent of their parent or guardian.
- 3. DBH criteria for recruiting and selecting minors is two-fold: minors must appear to be under age 21, dress as they would normally and avoid clothing and mannerisms that could be perceived as age related; minors selected should reflect racial or ethnic characteristics of the neighborhoods where tobacco outlets are located.
- 4. DBH requires that minors selected have valid government identification with a photo, the minor's name, date of birth and address. Minor's selected must carry their government identification (e.g., Motor Vehicle Driver's License or non-driver's identification card) when involved in the Synar Survey Inspections.

Training

- 1. NCCPUD updates annually a standard Training Manual approved by DBH. The curriculum for Compliance Check Team members (including the NCCPUD supervisors), provides an overview of the health and legal consequences of underage tobacco use, Synar requirements, and protocol including roles and responsibilities. DLCP, the youth inspectors, and the contracted organization are all guided by procedural requirements to ensure optimal safety during all aspects of the Synar inspection process. Responsibilities are as follows:

DLCP is responsible for:

• Serving as onsite lead for the inspections.

• Providing two inspectors for each team who drives from location to location in a separate vehicle from DBH staff.

• Ensuring that the youth have their valid identification card with them prior to conducting inspections.

• Identifying a code word or emergency signal for both DBH and the youth. This word or signal will be used if any problems arise or if any of the Compliance Team members feel uncomfortable during inspection operations. If the code word is radioed or emergency signal utilized, the operation is halted.

The youth inspectors are responsible for:

• Showing their valid identification card if the store employee makes a request for identification.

• Not misrepresenting or lying about his/her actual age either verbally or by documents at any time during the compliance check operations.

• Not arguing with, entice, or induce the store employee into selling tobacco products. If a store employee refuses to sell the tobacco product, the youth must immediately depart from the premises.

• Immediately exiting the premises if a store employee sells the tobacco product and turn over the tobacco product (evidence) to the DBH staff person.

• Not having contact with the DLCP inspectors while inside the store. The inspectors will maintain visual contact to ensure the youth's safety and close enough to overhear the conversation between the youth and the store employee. This assists the inspectors with documenting specifics if the sale is completed.

NCCPUD is responsible for:

• Annually updating a standard SSIP Training Manual approved by DBH. The curriculum for Compliance Check Team members (NCCPUD supervisors, minors, DLCP, and DBH staff), provides an overview of the health and legal consequences of underage tobacco use, Synar requirements, and SSIP protocol including roles and responsibilities. DBH and NCCPUD maintain a copy of the SSIP Training Manual that is available upon request.


• Providing annual mandatory trainings for the Compliance Check Team according to pre-determined dates in the annual work plan.

b. Describe the sampling methods.

The following sample design was used by the District of Columbia (DC, District) to measure the quality of the list frame (Licensed Tobacco Retailer List maintained by the Department of Consumer and Regulatory Affairs) currently used for Synar compliance checks. DC plans to use an area frame for this coverage study that coincides with a systematic sample design that separates DC's census tracts into three strata. The four sample selection steps for the coverage study are outlined below.

Step One – Breaking down DC's total population in into 206 census tracts each with a population of 100 persons or more based on the "Census Tracts in 2020," dataset located in the DC Open Data Catalog maintained by the DC Office of the Chief Technology Officer.

Step Two – Stratifying the census tracts by sorting them in ascending order by population so that low, medium, and high census tract populations could be identified. Consequently, census tracts with a population between 176 and 2,820 created the first stratum; census tracts with a population between 2,836 and 3,712 created the second stratum; and census tracts with a population between 3,748 and 6,459 created the third stratum. There were 68 census tracts in the first stratum, 69 in the second, and 69 in the third.

Step Three – Using a systematic random sampling design to select the census tracts included in the coverage study. There were 712 tobacco retailers in DC that were used in this coverage study. Assuming each census tract has an equal number of tobacco retailers, DBH divided the 712 stores by 206 census tracts, which came to an average of 3.46 tobacco retailers per census tract. DBH divided 206 by 3.46 to determine the number of census tracts to include in the coverage study. This yielded 59.53 census tracts and 206 outlets (multiply 59.53 by 3.46 to get approximately 206 outlets). DC is a small geographic area with budgetary restrictions on conducting the coverage study, and sampling 206 census tracts was deemed too cumbersome. To reduce DC's burden when conducting the study, DBH consulted SAMHSA's sample size determination chart, and sampled a total of 512 outlets in 40 census tracts. A sampling fraction of 1/5 was utilized, (206/40 is approximately 5) and we selected every fifth census tract (starting with the census tract assigned the number 1 from a random number generation program).

Step Four – *Generating street maps with the census tract boundaries clearly marked.* A canvassing path will be drawn on each map by the project director using lines and directional arrows to ensure efficient and comprehensive canvassing strategies for each tract.
