## **Overview**



A total of 165 unique participants registered for at least one CoP meeting.

A total of 132 unique participants attended at least one CoP meeting.

A total of 33 unique participants registered, but did not attend the meetings.

A total of 48 unique participants attended more than one meeting.

## Supplemental Statements and Tables

- ➤ Of the 165 participants who registered for CoP meetings, 21 were CBO-Administrators, 36 were CBO-Clinicians, 37 were from DC Charter Schools, 30 were from DC Public Schools, and 41 identified as other.
- ➤ Of the 132 participants who attended at least one meeting, 15 were CBO-Administrators, 29 were CBO-Clinicians, 27 were from DC Charter Schools, 24 were from DC Public Schools, and 37 identified as other.
- ➤ Of the 33 participants who registered, but did not attend a CoP meeting, six were CBO-Administrators, seven were CBO-Clinicians, 10 were from DC Charter Schools, six were from DC Public Schools, and four identified as other.

- ➤ Of the 48 participants who attended more than one CoP meeting, five were CBO-Administrators, seven were CBO-Clinicians, 10 were from DC Charter Schools, six were from DC Public Schools, and four identified as other.
- ➤ A total of 84 participants attended one CoP meeting, 36 participants attended two CoP meetings, 11 participants attended three CoP meetings, and one participant attended four CoP meetings.
- ➤ A total of 51 participants attended the November CoP meeting, 20 participants attended the December CoP meeting, 69 participants attended the January CoP meeting, and 53 participants attended the February CoP meeting.
