- Question What equipment is allowable in the budget? Answer A CBO may budget under indirect costs to purchase such equipment as a personal air purifier for the clinician's office.
- 4. **Question** Are CBOs allowed to apply for this RFA without attending the pre-application conference?

Answer A CBO may apply as the pre-application conference attendance is not mandatory yet strongly encouraged. Additionally, the Intent to Apply Notification is part of the fillable PDF and will be submitted with the application.

5. Question May a supervisor receive the one-time payment of \$1000 for workforce development?

Answer The workforce development one-tine \$1000 funds must be used for clinicians only and fund within the scope of what is described on page 10 of the RFA.

- 6. Question If the funds of the grant are to support salaries, how do you budget for travel? Answer A CBO may budget under indirect costs the travel of a supervisor to schools to conduct supervision and attend meetings at the school of the supervisee.
- Question On the budget form, I see two tabs for the budget. Are we supposed to fill both out?
   Answer The second tab in the budget form is for additional space per category. If the

data takes up all of the space in a section on the first Tab, then you can continue the information on the second Tab in the same section.

- 8. Question With regard to being a Medicaid provider, is having a Medicaid number enough to be considered for the opportunity? Answer The Community Based Organization has up to 90 days after the award to be enrolled as a Medicaid provider and a participating provider with the Department of Health Care Finance. - 9. Question Is there flexibility around full paneling with all MCO's? Answer The Community Based Organization has up to 90 days after the award to be contracted with all Medicaid Managed Care Organizations (MCOs). (See Also: RFA submission, Page 14)
- 10. Question Can a provider be paneled with some but not all? Answer The Community Based Organization has up to 90 days after the award to be contracted with all Medicaid Managed Care Organizations (MCOs). (See Also: RFA submission, Page 14)
- **11. Question** Can a provider have a contract for some services but not all services with an MCO?

Answer The contracted services with the Managed Care Organizations (MCOs) are to include Diagnostic Assessments and the modalities of individual therapy, family therapy, and group therapy. Please note that the services identified on an Individualized Education Plan (IEP) or 504 Plan are not provided by the DBH Grantees.

**12. Question** Can a provider partner with a company (i.e. subcontract) who is fully paneled with all MCO's?

Answer A Community Based Organization that is a DBH Grantee within the School-based Behavioral Health Program is allowed to sub-contract.

- 13. Question Some documents say the application submission deadline is 2/3 and some documents says 2/6. Which is one we should follow?
  Answer Please follow the deadline for submitting an application of: Friday, February 3, 2023 by 12:00 PM ET. Applications received at or after Friday, February 03, 2023, 12:01 PM ET, will not be accepted as a submission. (See Also: RFA Submission, Page 27)
- 14. Question For our UEI number, is providing proof that we applied for the number and assignment is pending, sufficient? Or, are we required to have the UEI number when submitting the application? Answer The Applicant must provide documentation of an active UEI or provide

documentation that the UEI has been requested. If awarded funding, documentation of an active UEI is required.

15. Question What is the purpose of the Advance Payment Request form (Attachment G)? Answer An applicant seeking an advance, submits a completed Advance Payment Request form (Attachment G) with the submitted application and it is signed by the organization's Chair of the Board of Directors and Executive Director, or equivalent positions.
