7. Question Is there a curriculum developed to implement the pilot or are CBOs able to create their own implementation plan?

Answer There is no curriculum that the Department of Behavioral Health has developed for use in the pilot. Page 24 of the RFA notes the evaluation criteria and applicants have the opportunity to provide "information on any evidence-based programming that will be used to train peer educators, as well as the evidence-based programming that will be utilized by the peer educators at school."

8. Question Are CBOs that don't have staff at every school eligible to apply for this opportunity?
