Solicitation RM-09-RFQ-074-BY-THS is hereby amended as follows:


1. Section J.7 DRAWINGS, has been added, with the following attachments:

- The Rubber Flooring Specification that must be replaced at the floor penetration within the New Hospital. The Owner will provide the flooring. All other materials must be provided by the Contractor.
- Sketch CA-C-005 which adds the sanitary line from the Pump House.
- Sketch CA-C-006 which identifies all manholes relevant to this proposal.
