12		What is the requirement for eCura?

DMH RESPONSE: The Contractor shall need access to Provider Connect which interfaces with eCura. Contractors awarded a contract who are not DMH providers must be certified to use Provider Connect by DMH. Once certified, DMH shall set that Contractor up in our system, and with the established rate, provide the billing code for this service. Sub-providers shall receive two free licenses for use from DMH. There is a testing period provided by our IT department before initiating billing through eCura. Providers may use Easy Claim or their own billing software package. Authorization numbers are provided by Access Helpline to residential crisis providers for all admissions beyond 48 hours. Residential crisis providers may also look up authorizations numbers via Provider Connect. Authorization numbers are used to bill electronically for this service (not treatment numbers).
