- **File #4** – 501(c)(3) Letter, Articles of Incorporation & Bylaws, IRS W-9 Form, IRS Tax Exemption Letter, Current Fiscal Year Budget, Financial Statements, and Separation of Duties Policy.

- **File #5** – Board of Directors, SAM Registration, Attachment 2-Pages 63 & 64*, Attachment 3*, Attachment 4*, Attachment 5*, Attachment 6*, Attachment 7*, Attachment 8*, and Attachment 9*.

Please note: You do not have to provide Attachment 1 – Terms and Conditions in the submission.

If you are able to email documents in fewer files, please feel free. If you need to send multiple emails, that is acceptable.

We must receive all files before the submission deadline of Monday, September 28, 2020, 5:00PM ET.
