1	SECTION G.2.1	<p>The explanation given in Amendment 3, Question #16 still does not sufficiently clarify the question regarding why the bidder receiving this contract cannot hire regular full time employees, but must hire staff as contractors. It is clear that the staff will not be District Government staff because they will be staff of the Contractor/Entity who wins the award and hires its own employees. Other contracts for services with DBH do not have this requirement, so can the District please share the rationale for this decision. It will place an unfair burden on employees of the CFAC.</p>
<p>DBH RESPONSE: Upon reexamination of Section G.2.1, DBH has determined that a Vendor choosing to participate in this RFP process to provide Consumer Focused Activity Center Services must make a Staffing decision at the Vendor's discretion concerning their hiring practices associated with their response to this RFP Solicitation.</p> <p>A Vendor has the opportunity to choose to hire Staff Personnel or Contracted Personnel based upon their Organization Personnel policies & practices. Vendors participating in this Solicitation must specify in their response to the RFP their organization's personnel policies regarding hiring of Full Time and Part Time Personnel or Contracted Personnel, along with payment for Holidays and Sick Leave, along with identifying the direction being taken by the Organization as it relates to this RFP. This information must be included in their Price Proposal and supported by a detailed budget narrative.</p>
