Message from the Director



Dear DMH Employee,

Spring is a busy time for the Department as several initiatives are coming to life. I am very excited that through our work with

DHCD, 97 new housing units for the exclusive use our consumers are in the pipeline—and the first tenants could move in next May. You can read more about this initiative on page 2.

And, for the first time in the District, a community based, consumer focused activity center is scheduled to open, and we look forward to the Open House Ceremony early this summer. After a competitive bid process, the Ida Mae Campbell Foundation was selected to operate the center. In her first days on the job, Vivi Smith, our new Director of the Office of Consumer and Family Affairs, made this project a major priority, Please take a moment to welcome Vivi to DMH.

We expect that the Urgent Care Clinic at Superior Court will open within the next several weeks. This will make a big difference in our ability to link people who have been involved in the judicial system and unable to access mental health services in a timely fashion. The Psychiatric Institute of Washington has been selected as the operator.

We are close to making a decision about our choice providers for children and expect the program to be operational in June or July.

With these initiatives, we are addressing gaps in services and moving toward our goal of establishing the most responsive public mental health system possible.

Mayor Fenty Joins Director Baron to Announce New Supportive Housing

Mayor Adrian M. Fenty joined Director Baron on May 1 to announce a new initiative to create 300 units of affordable housing for the exclusive use of DMH consumers. DMH will transfer \$14 million to DHCD to help finance the creation or renovation of new affordable housing units over the next three years.

Mayor Fenty, Director Baron and Leila Finucane Edmonds, DHCD Director, announced the partnership at the site of a new housing project that will be developed by SOME. Ward 7 Councilmember Yvette Alexander also attended.

"We are committed to ensuring that District residents in need of public mental health services receive the support they need," said Mayor Fenty in a statement.

700 people with mental illness now receive a housing subsidy from DMH according to **Edith Makenta**, Director of Supportive Housing. The partnership with DHCD will increase the number of residents receiving housing support by 50 percent.

"We've heard over and over that access to affordable housing is the number one desire for individuals with mental illness, said Director Baron. "This partnership with DHCD will help us address access, and we will continue to provide flexible mental health services and support when wanted or needed."

Some DMH consumers could move into new homes as soon as May 2009 as DHCD will approve funding for 150 supportive units this year. Funding for the remaining 150 units will be put in place within two years which would allow consumers to occupy those units within 36 months.

Employee Spotlight: Harriett Sesay, Justine Njafuh, and Roxanne Froneberger

Three nurses on the night shift at Saint Elizabeths Hospital are piloting a major reform initiative taking place at the hospital—trauma informed care. And, they are making a difference in the quality of patient care.

Ms. Harriet Sesay, Ms.Justine Njafuh, and Ms. Roxanne Froneberger have a combined total of 41 years at the Hospital. While they came to the Hospital from different paths, they share a common passion for helping people. All three said they enjoy working with the patients and value their relationships. Ms. Njafuh makes a point of wearing bright colors because the patients like it.

Each nurse helps a patient develop a safety plan, identify triggers that might traumatize her (whether situations or emotions) and make sure staff is aware of them so they don't do anything to retraumatize the patient.

Ms. Froneberger who has worked 13 years at the Hospital said that she sees the changes that are taking place, pointing out recent upgrades and hiring new staff.

Ms. Njafuh added that supplies are now adequate and maintenance is much improved.

Ms. Sasay, a native of Sierra Leone, came to the Hospital after taken a medical training course. She chose the night shift because it suits her family schedule.

"We are going to become a trauma informed hospital," CEO Dr. Canavan said emphatically. "We recognize that the majority of people who have been psychiatrically hospitalized have experienced trauma. These three nurses have a unique ability to help people plan for difficult situations and help prevent them. They are consistent in how they manage situations and demonstrate care and competence in all they do.

DC Nurses Association and Saint Elizabeths Sponsor Nurse Training

The District of Columbia Nurses Association (DCNA) and Saint Elizabeths Hospital are sponsoring a leadership training conference for nurses on Thursday, May 8, 2008, in the Hospital's Chapel. The conference, entitled "Nursing Leadership: Challenges for the Future", takes place during National Nurses Week, started by the American Nurses Association to honor the Nation's nearly 2.9 million registered nurses.
