

I want to call your attention two very important events taking place next week—the 8th Annual Mental Health Conference on Monday, June 22 and the 2009 Dixon Child-Youth Review and Practice Development Workshop on Wednesday, June 24.

Sponsored by the State Mental Health Planning Council, the conference brings

together the mental health community to discuss strategies to address critical issues. This year's conference will focus on housing and job opportunities—among the biggest challenges that we hear from consumers. I intend to focus my remarks at the conference on the results of the recent children/youth community service reviews that reaffirmed the absolutely critical need for good team formation and team functioning. Saint Elizabeths Hosts 2nd Annual Walking Tour

Under sunny skies, the 2nd annual walking tour of Saint Elizabeths on May 30 attracted nearly 100 participants eager to learn more about the history and future plans of one of the most beautiful landmarks in the District. Participants came from various walks of life—including a graduate student from a local university, avid history buffs, retirees, and a former Hospital employee from the 1980s.

Because of its size, the tour was divided into two groups to facilitate interaction with **Dr. Jogues Prandoni** and **Dr. Surya Kanhouwa**—Saint Elizabeths historians who led the tour. As always, the history of the Hospital stirred the people who were there.

One person asked if the Hospital could make the presentation at her Senior Citizens Home. Several others were so excited about the tour that they asked about volunteering at the Hospital!

Employee Recognition: An article by **Julie Goldstein-Grumet**, Project SUICIDE director, and her former evaluator **Melanie Brown** titled "Schoolbased suicide prevention with African American youth in an urban setting", recently was published in Professional Psychology: Research and Practice. Vol 40(2), Apr 2009, 111-117. An abstract is reprinted below:

Abstract: Youth in urban settings are at significant risk for suicide and other mental health issues, but little is known about the utility or outcomes of suicide prevention programs with this population. This article reviews the outcomes of a grant-funded initiative to provide suicide screening to urban, African American youth. Columbia TeenScreen was implemented at 13 middle and high schools in Washington, DC, to 229 Black or African American students. Forty-five percent of students screened positively for previous suicide attempt or ideation, symptoms of depression or anxiety, and/or other emotional problems. Twenty percent of all youth screened endorsed current or previous suicidal ideation or attempts. Over 90% of youth endorsed at least some problem with depression or irritability. Early detection of risk factors through universal screening can lead to earlier treatment, thwarting a suicidal crisis. Implications for conducting screening in an urban setting and how psychologists can engage in screening are explored. (PsycINFO Database Record (c) 2009 APA, all rights reserved)

Mayor Fenty Recognizes National Consumer Memorial Campaign Kick Off at Saint Elizabeths

Mental Health America, other national advocacy organizations and local consumer action groups held a dedication ceremony for a national consumer memorial to honor hundreds of thousands of patients buried at state psychiatric facilities across the country—many in unmarked and neglected graves. Saint Elizabeths Hospital was selected as the site of the memorial in recognition of its historic leadership in moral treatment, and DMH staff is actively supporting the project. To honor the occasion, Mayor Fenty proclaimed June 10 National Consumer Memorial Day in the District.

The Gardens at Saint Elizabeths—A National Memorial of Recovered Dignity will be woven into the Hospital cemetery where more than 4,500 patients are buried including about 1,800 veterans dating back to the Civil War. The memorial will include metal markers surrounded by gardens and a pool of water from all 50 states and the District of Columbia that list the number of patients buried and at which institutions.

A granite marker bearing the quote "I must fight in the open" from Mental Health America founder Clifford W. Beers was unveiled as a permanent part of the memorial. Construction on the memorial will begin in 2010.
