Martha B. Knisley, Director, DC Department of Mental Health

When Mental Health Director Martha B. Knisley announced the creation of a new awards program for the Department of Mental Health, she spoke about the importance of recognizing outstanding service and job performance: "There are lots of hands and talents involved in the creation of a new multioperational mental health service delivery system. That's why it's important, all along the way, to acknowledge and recognize the contributions of employees on the team, as well as consumers, supporters and advocates."

Awards will be presented on a quarterly basis throughout the year in six distinct categories. Included in the categories is a "SOS Award" – Support Our Services – to recognize extraordinary performance in providing support and assistance to the Mental Health Authority. The first "SOS Award" recipient is Leonard Higgs for his support of a new financial accounting initiative implemented by Director Knisley.

Meanwhile, the first "Customer Service Award," for extraordinary performance in providing consumer support and assistance, was presented to the Access HelpLine staff, directed by Jane MacLean. The "Mission Award," for extraordinary performance in helping the Department meet its mission, was presented to the Supported Employment Program, under the direction of Elizabeth Jones. A "Celebration Award," which recognizes extraordinary performance in providing services to children and families, was presented to the School Integrated Mental Health Program, led by Olga Acosta, Ph.D. The "Access Award" for extraordinary performance in providing access
